RE: Tuition Rate Setting Timeline and Process

As communicated July 5, 2023, WSU has modified its timeline for Board of Regents consideration and approval of tuition rates. In a continuation of this process, Resident Undergraduate/Graduate and Non-Resident Undergraduate/Graduate tuition rates will be presented to the Board of Regents on a different timeline than the tuition rates for professional and self-sustaining programs. This split timeline allows WSU to publish primary tuition rates and colleges to receive student feedback on other proposed tuition changes. Please see the following timeline:

Board of Regents Timeline:

- September 2024
 - o Future Action Item regarding AY2025-2026 U/G Res/Non-Res Tuition
- November 2024
 - Action Item regarding AY2025-2026 U/G Res/Non-Res Tuition
 - Future Action Item regarding AY2025-2026 professional and selfsustaining tuition
- January 2025
 - o Action Item regarding AY2025-2026 college/program tuition

If you wish to propose a tuition rate increase, you must complete the template on the following page and return it to the Budget Office (<u>wsubudget.office@wsu.edu</u>) by **October 11, 2024**. The Budget Office will coordinate the collection of materials and prepare the Regents agenda items.

Remember that you must gather and consider student feedback for any proposed increases. You should plan to finalize the collection of student feedback by December 13, 2024 to meet the deadline for January meeting materials. Student feedback will be shared with the Board prior to final adoption of rates in January 2025
